

# NEUTRA



## DESCRIPTION

NEUTRA is a clear alkaline solution (pH 10) which has similar chemical properties to ammonia but does not have the pungent odour. NEUTRA is used to neutralize mineral or organic acid residues remaining in brickwork. The action of NEUTRA eliminates the acid fumes which slowly come out of brickwork and attack internal metal fixtures or leave a white, powdery layer over objects inside a house or building.

## PRECAUTIONS

Mask off any metal surfaces, painted or plain, electrical fittings, woodwork, (painted or plain) and any painted surfaces.

**APPLICATION : USE NEUTRA AS SUPPLIED**  
Using a pressure garden spray applicator OR BRUSH. gently APPLY NEUTRA evenly over the brick wall so it is well wetted but not running down the wall. Coverage rate as a guide is 0.5 - 1.0L/m<sup>2</sup>. This range of rates depend on the porosity of the bricks and mortar in the wall. TWO COATS MAYBE NECESSARY. Let the applied NEUTRA solution sit on the brickwork for approximately 5 - 10 minutes before washing down with a low pressure water wash (generally light pressure blast or hose) this action washes the NEUTRA into the brickwork more effectively. The treated wall, when dry should be tested with litmus paper to determine its final pH. It should be in the region of 7 -9. The resultant wall can be plastered or painted in the future if desired.

## STORAGE

NEUTRA as supplied can be stored in metal or plastic containers. STORE UNDERCOVER, IN A COOL ENVIRONMENT, AWAY FROM FOODSTUFFS.

**HANDLING AND SAFETY :** NEUTRA is alkaline and can cause injury to eyes and irritation to the

skin. Operatives should wear protective clothing, impervious gloves and goggles. Vapour toxicity of NEUTRA presents no hazard at ordinary temperatures. Do not heat NEUTRA for use.

## FIRST AID

**SWALLOWED :** Give water or milk to drink in large quantities as soon as possible. Encourage vomiting.

**EYES :** Wash eyes for 15 minutes with copious amounts of water.

**SKIN :** Wash with copious amounts of soap and water.
